## **FORTERA CREDIT UNION SUPERVISORY COMMITTEE**

**2024 ANNUAL REPORT** 



Fellow Fortera Members:

The Supervisory Committee is composed of member volunteers and plays several critical roles at the credit union. The **Supervisory Committee** oversees a professional Internal Audit department,

who performs assurance work over the course of each year. We also engage qualified external auditors and consultants to perform additional projects, which provides a level of assurance commensurate with the credit union's size and complexity.

One of the Committee's most important tasks is engaging and overseeing an annual financial statement audit. We engaged Doeren Mayhew to perform this "external" audit for the year ending December 31, 2024. The credit union received an "unqualified" opinion, meaning the annual

financial statements fairly presented, in all material aspects, the financial position of the credit union, and conformed to generally accepted accounting principles. This opinion was based on extensive testing of controls and transactions, in accordance with generally accepted auditing standards. An unqualified opinion is also known as a "clean" opinion, and provides our members with comfort that the financial statements are free of material errors and omissions.

We believe, based on the cumulative results of assurance work performed, that the credit union is well positioned and will remain competitive. The Supervisory Committee is an advocate for, and representative of you, our members.




## **Ensuring Safety & Security**



Our Net Worth Ratio of 12.10% demonstrates our stability and should give members confidence in the long-term health of the credit union. Our net income rose to \$6,013,424, making this our most profitable year ever! We also experienced a strong 7.54% deposit growth. All these numbers allowed us to continue to invest in better services and technology, offer competitive rates and launch new member-focused financial solutions, like our Financial Wellness program. 
Members can engage with the chat feature by:

#### **EMPLOYEE VOLUNTEERISM**


Our team doesn't just work herethey live here, too. That's why we encourage and support employee volunteerism, giving our team members the chance to make a direct impact in the communities we love.
